

ORDINANCE NO. 288

AN ORDINANCE SETTING CERTAIN FEES  
TO BE COLLECTED IN THE VILLAGE OF LOCH ARBOUR,  
COUNTY OF MONMOUTH

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF LOCH ARBOUR as follows:

**Section 1.** Marriages, births, deaths and fetal deaths (still deaths) shall be reported to the Village Clerk in his/her capacity as registrar of vital statistics, upon forms supplied him/her and in accordance with the rules and regulations of the New Jersey State Department of Health. The Village Clerk, shall, upon request, supply to any applicant a certified copy of the record or any birth, death or marriage, registered under the rules and regulations of the New Jersey Department of Health, at the fee of five (\$5.00) dollars for each copy.

**Section 2.** (a) The fee for supplying copies of public records shall be based upon the total number of pages, up to and including pages 11 inches x 17 inches in size, or parts thereof, to be purchased for each individual report of separate record filed with the Village, not upon the ultimate number of pages provided.

- i. First page to tenth page           \$.75 per page;
- ii. Eleventh to twentieth page       \$.50 per page;
- iii. All pages over twenty           \$.25 per page.

(b) The fee for public records containing oversized pages (pages exceeding 11 inches x 17 inches) shall be ten (\$10.00) dollars for each page.

(c) Comprehensive land use ordinance and its amendments - \$20.00 per set.

**Section 3.** All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed, but only to the extent of such inconsistency.

**Section 4.** This Ordinance shall become effective upon its final passage and publication.
